_____ Applicant understands that if an applicant's bid is misrepresented to the Board of Directors for the Lawrence County Land Reutilization Corporation, applicant may be excluded from having any further eligibility to bid on properties.

_____ Applicant understands that this is not an auction, and the highest bid does not guarantee a winning bid, and the Lawrence County Land Reutilization Corporation may reject or table any bid for any reason.

_____ Applicant understands that a new survey may be required before the property can be transferred. If a new survey is required, the associated cost will be the responsibility of the purchaser.

_____ Applicant understands that all fees associated with the creation of any necessary legal documentation, county transfer or recording fees are the responsibility of the buyer.

IMPORTANT UNDERSTANDING: In purchasing a property; applicant is agreeing to maintain the property according to the established restrictive covenants.

All property is awarded and sold AS IS, under terms of General Warranty, unless specified by the Lawrence County Land Reutilization Corporation. A search of the property title is optional but, at the expense of the Purchaser. Unless approved by the Board, all survey costs, closing costs, attorney fees or fees of by County of Lawrence, to facilitate the sale and transfer, are the responsibility of the Purchaser.
